In consideration of renting AshKay Island, and for use of the facilities and amenities on the island, I agree to the following waiver and release and I specifically make the following representations:

I EXPRESSLY ASSUME THE RISK OF PERSONAL INJURY ASSOCIATED WITH USE OF ASHKAY ISLAND AND ITS FACILITIES. _____

I understand that the use of the island has inherent risks, such as the risks of being near water, and the risk of boating, swimming, and diving. I understand that the zip line and rope swing also carry inherent risks. I understand that the risks include personal injury from falling, equipment failure, bad decision making, natural disaster, inexperience, and other ordinary risks. ***I UNDERSTAND THAT THE ACTUAL DANGERS MIGHT BE UNFORESEEN, AND I EXPRESSLY ASSUME THE RISK OF UNFORESEEN DANGERS.*** _____

I am physically healthy enough to camp and boat and to use the amenities and facilities of AshKay Island. There is no reason why I should not participate in the activities on the island. _____

I HEREBY RELEASE ASHKAY ISLAND LLC ITS OWNERS, OFFICERS, EMPLOYEES, AND AGENTS FROM ALL LIABILITY FOR ANY PERSONAL INJURY THAT I MAY HAVE, INCLUDING INJURIES RESULTING FROM NEGLIGENCE OF ASHKAY ISLAND LLC, ITS AGENTS OR EMPLOYEES. _____

RELEASE FOR MY CHILD: By signing this document, I release ASHKAY ISLAND, LLC, its owners and employees from all liability for any injury to myself or to my child to the fullest extent allowed by Michigan law. I agree to indemnify and hold harmless ASHKAY ISLAND LLC and the other parties released if a minor member of my family sues them or any one of them. I understand that my agreement to indemnify obligates me and I agree pay all of the costs, fees, and charges incurred by ASHKAY ISLAND LLC and the other parties released, including attorney fees.

OBLIGATION REGARDING OTHER CHILDREN IN MY CARE. I will have the parent or guardian of each child in my care sign a release like this one. I understand that if I do not have a signed release for each child in my group, ASHKAY ISLAND LLC can refuse to allow such a child to participate in the activities on the island. I understand that ASHKAY ISLAND may choose to permit a child without a release to participate in the activities on the island, but only if I assume full responsibility for the safety of the child, and agree to indemnify and hold harmless ASHKAY ISLAND, LLC and the other parties released if the child is injured. _____
